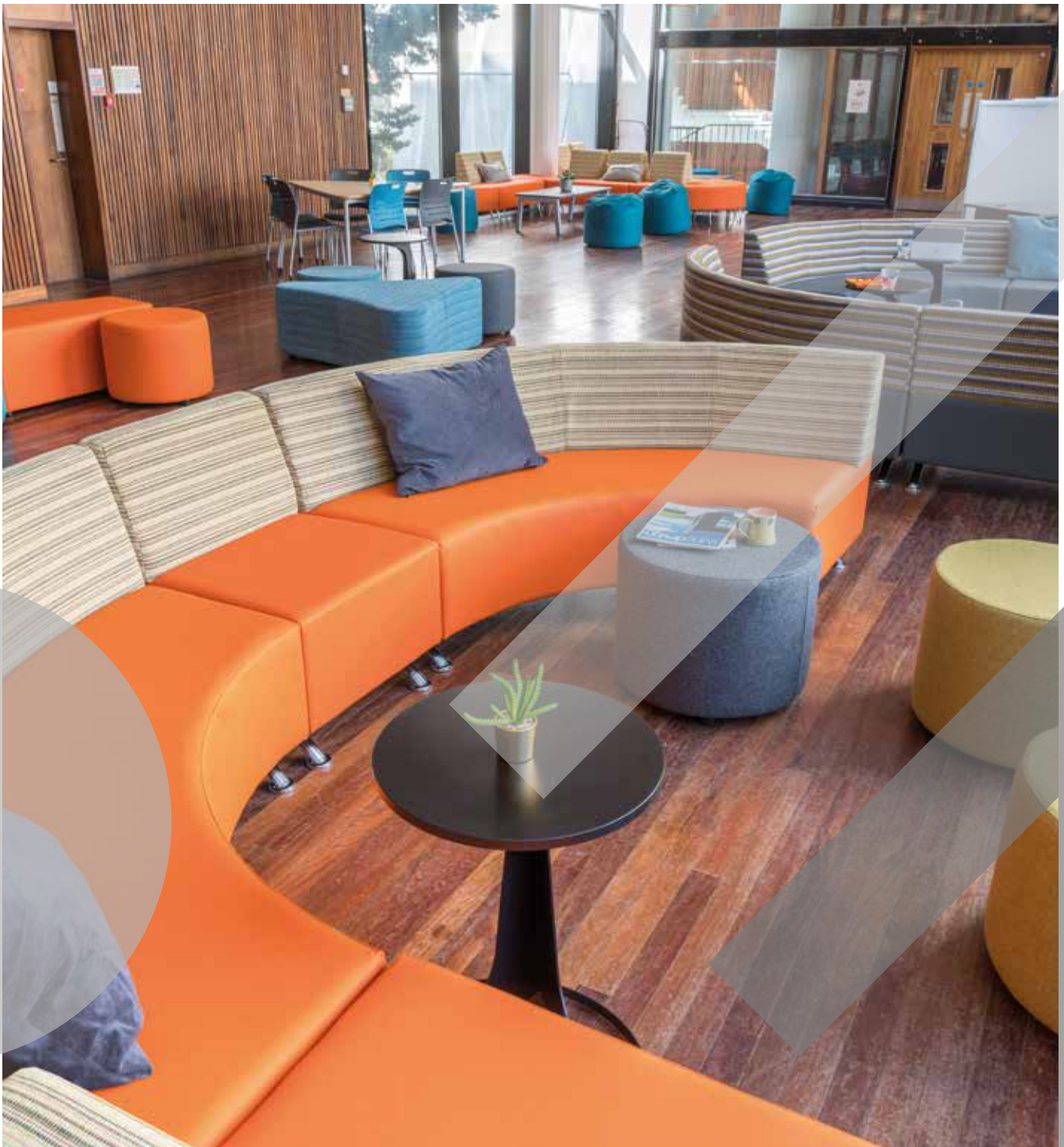

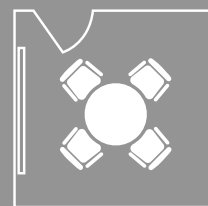
Delivery is FREE to your premises – ground floor only. The driver making the delivery will be unaccompanied and may require assistance when unloading.

Space Planning

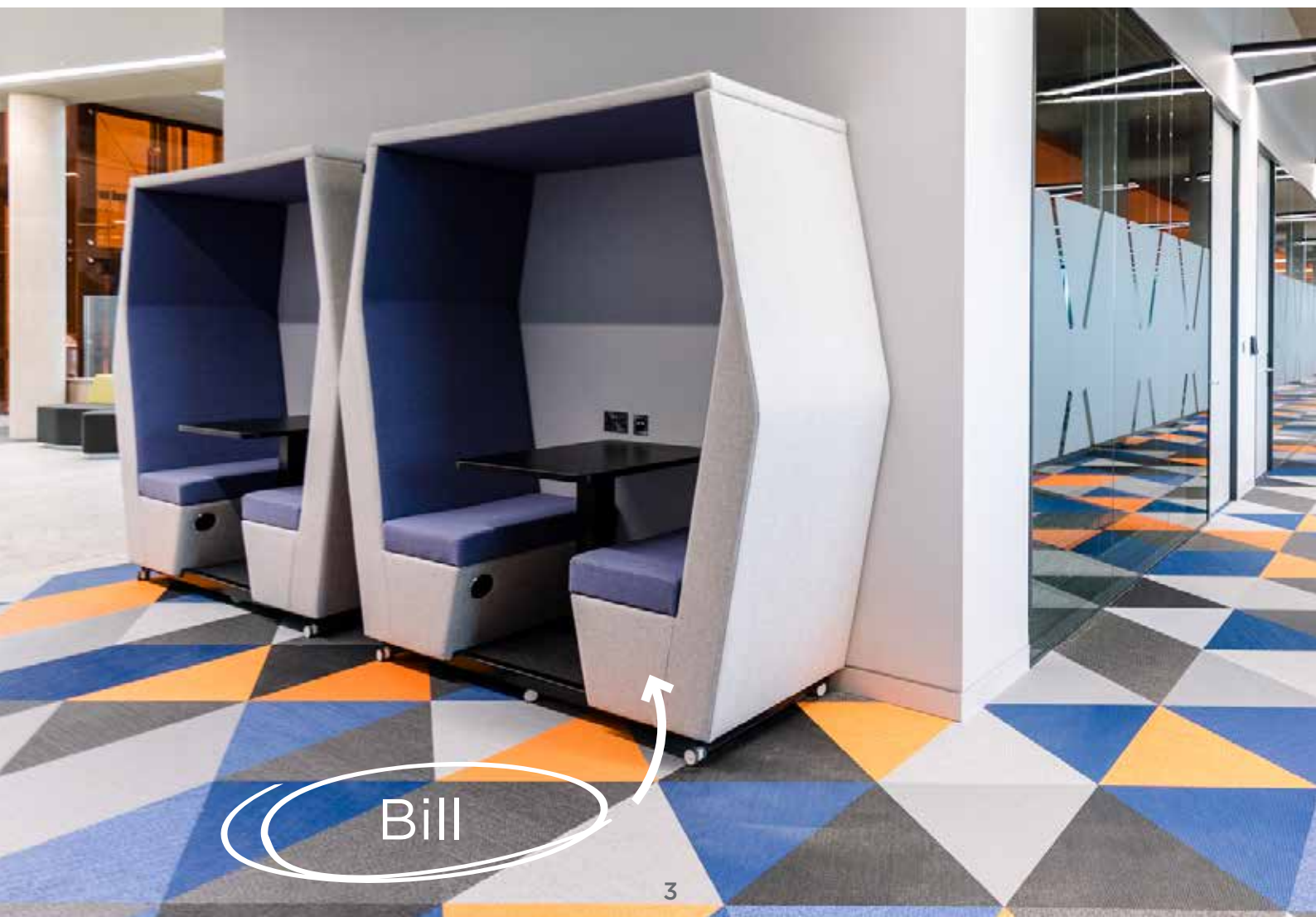
Our in-house space planning team is available to produce drawings in 2D and 3D. Presentations can also be prepared for larger projects incorporating images and colour schemes.

SUMMARY OF SALES TERMS AND CONDITIONS

1. Prices

Alpha Marketing Ireland Ltd., reserves the right to vary any of the prices on its issued Price List without prior notice. Orders are accepted on condition that goods will be invoiced at prices ruling at the date of despatch. Save with the prior written agreement of a director of the Company all prices and any discounts quoted by the Company or any of its representatives whether oral or in writing, are made on the basis that the resulting amounts invoiced must in all circumstances be settled in full by the Customer within thirty days of the date of the invoice. In all circumstances the amount of V.A.T. shown on the invoice must be paid in full.

2. Payment

Payment for goods shall become due thirty days from date of invoice and is strictly nett. If the Customer shall fail to make full payment on the due date, the Company shall be entitled to charge interest on the amount due from the date of invoice to the date of actual payment after as well as before any judgement obtained at the rate of one and a half percent per month calculated on a daily basis. If the Customer shall fail to pay in full within sixty days from date of invoice, the Customer shall reimburse the Company for any expenses reasonably incurred by the Company in the collection of all sums due. All cheques to be made payable to Alpha Marketing Ireland Ltd.

3. Value Added Tax

The Customer shall be responsible for V.A.T. on all orders at the prevailing standard rate on the invoice values at the time of despatch and where such agreement has been granted, the cancellation will be subject to a 25% cancellation charge.

4. Cancellations

Orders, in whole or in part, can only be cancelled with the written agreement of the Company. In cases where goods not normally stocked have been ordered specially, e.g. chairs covered in a Customer's selected upholstery, or special items of equipment the Company may not then be in a position to accept cancellation and in any event shall not be so obliged.

5. Carriage

In the event that a Customer requests that delivery of goods be made to an address other than that of the Customer, the Company shall be entitled to make an additional delivery charge and to require that assistance be available for off loading the goods.

6. Damage and Short Delivery

The Company shall not be obliged to entertain any claims of goods being delivered damaged or short delivered, unless the Customer notifies the Company in writing, quoting the delivery note number and such notice is received by the Company within seven days of the date of delivery. All damaged articles must be returned to our depot carriage paid within 1 month of despatch.

7. Delivery

Delivery times quoted are given in good faith and although the Company will make every effort to deliver on the dates given it does not accept liability for failure to do so. The Company shall be entitled to make partial deliveries and to invoice the Customer accordingly. Payment of such invoices shall be due and payable on the same terms and in the same manner as applicable to an invoice for the full delivery.

8. Specification and Continuity of Product

The Company cannot be held liable in any way whatsoever for:-

- (a) changes in specification made by its manufacturing suppliers, or
- (b) the discontinuance of any particular line.

The Company shall make all reasonable efforts to notify the Customer of such events if it becomes aware of the same.

9. Reservation of Title

(a) Legal title and ownership in the goods shall remain with the Company until the Customer shall have paid the Company in full respect of all accounts of any nature outstanding by the Customer with the Company.

(b) Until payment in full aforesaid shall have been made, the Customer shall have possession of the goods as bailee for the Company and shall have authority until such authority is countermanded by the Company, to sell the goods on behalf of the Company to third parties at arms length in the ordinary course of the Customer's business. The Customer shall hold all proceeds of such sales in trust for the Company and shall maintain such proceeds separately identified. The Company shall be entitled to all rights and claims which the Customer may have against its customers arising from such sales until payment aforesaid is made in full. (c) The Customer shall store the goods in such a way as to enable them to be identified as the property of the Company.

(d) For so long as any payment is overdue, the Company shall be entitled to enter upon any premises where the goods are located and to take possession and resell the same and for this purpose the Customer hereby grants the Company irrevocable right and licence to enter upon any premises where the goods are located. This right shall continue to subsist notwithstanding termination of this Contract for any reason and shall be without prejudice to any accrued rights of the Company.

(e) Notwithstanding these provisions for reservation of title, risk in the goods shall pass to the Customer on delivery.

10. General

Unless and until terms and conditions shall be further modified, they shall apply to any order accepted by the Company save to the extent that the terms for an order other than prices and or discounts as varied in condition 1 hereof, shall have been first agreed to in writing by a director of the Company.

11. Environment

Opportunities are sought to always purchase timbers and veneers from renewable and sustainable sources. Chipboard used is of E1 category in order to reduce harmful chemical emission during the manufacturing process. Purchasing policy on new plant and machinery ensures the minimum impact on the environment. All company cars have been converted to use lead-free petrol. Liaison continues with all regulatory bodies and trade associations.

All orders received will be placed within 48 hours of receipt, and an order acknowledgement will be notified for confirmation.
